Dear Speaker Pelosi and Majority Leader Schumer:

The COVID-19 pandemic has laid bare the harmful consequences of policies that deny people access to health care and other basic services and supports based on immigration status. We write to support legislation to protect the nation's health and prosperity by eliminating long-standing barriers that have denied people who are lawfully present in the U.S. and their families the basics we all need to thrive. We call on Congress to support and quickly enact the Lifting Immigrant Families Through Benefits Access Restoration (LIFT the BAR) Act upon its introduction.

The LIFT the BAR Act restores access to public programs like Medicaid, CHIP, and SNAP, by removing the five-year bar and other barriers that deny critical care and aid to people who are lawfully present and their families. This includes people who hold "green cards," Deferred Action for Childhood Arrivals, crime victims, child maltreatment victims and orphans who hold Special Immigrant Juvenile Status (SIJS), and other noncitizens residing lawfully in the United States.

The legislation also ensures that sponsored immigrants have access to services based on the income and resources that are actually available to them. And it ensures that people across all states have similar access to the basic protections extended by federal safety net programs, while restoring state and local flexibility to provide benefits to immigrants with their own funds.

Research has shown that years of policies that target people because of their immigration status have deterred immigrant families, which include millions of U.S. citizen children, from health care and other basics. While the Trump Administration's disastrous public charge policy was the latest example, the five-year eligibility bar imposed by the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (PRWORA) has harmed more families since its enactment, a quarter-century ago. By denying health care and aid to otherwise-eligible people who are lawfully present, the five-year bar sets a dangerous precedent that makes the social safety net inaccessible to millions of families of color.

As the nation reckons with a legacy of racial injustice, any reform effort that fails to address the inequities facing immigrants is doomed to fail. Nearly 1 in 10 Black people in America are immigrants, and immigrants account for 24% of Native Hawaiians and Pacific Islanders, 33% of Latinos, and 66% of Asian Americans. Take into account their spouses and children, and it's easy to see that there is no justice for families of color until there is justice for immigrant families.

The injustice of PRWORA's five-year bar is compounded by the fact that it denies critical aid to people who are lawfully present including those who have served as essential workers during the pandemic. Many of the health care workers, child care workers, and educators who have kept our communities going have struggled to keep their own families afloat because the five-year bar denies them these basics.

President Biden took a major step forward in ending the harmful public charge policy, but we must work proactively towards addressing a much longer standing injustice by ending the five-year bar. By doing so, Congress will be helping millions of immigrants who are lawfully present and their families to get the quality healthcare, nutritious food, safe homes, and economic security every family needs to thrive.

A quarter-century is more than long enough to wait. We stand ready to partner with you to quickly move this legislation forward this year.
